RECOMMENDED ACTION:	Select four or more individuals as finalists for the position of President of the University of Nebraska
PREVIOUS ACTION:	None
EXPLANATION:	In March, 2014, the Board of Regents outlined its process for a national search for the next President of the University of Nebraska. The executive search firm Isaacson, Miller, Inc. was retained by the Board to help identify, recruit, assess and recommend candidates for the presidency. Two presidential search committees, comprised of 34 representatives of key constituencies with whom the president interacts, were appointed by the Board to assist with the search.
	The Presidential Search Outreach and Advisory Committee met regularly from April to July, 2014, to solicit stakeholder input on issues facing the university and qualities the university should seek in the next president, seek nominations and applications for the position, and determine how well potential candidates met criteria for the position established by the Board in the presidential profile which was released in June.
	The Presidential Search Screening and Selection Committee began meeting regularly in August, 2014, to review and evaluate candidate application materials, interview leading prospects and review reference checks. The committee is now preparing to potentially select no fewer than four candidates who will agree to become public finalists for the position.
	Finalists, if any, will only be identified by name in the event a member of the Screening and Selection Committee makes a Motion to select such finalists. Such Motion would be made in open session.
	Final selection of the next president will be made by the Board of Regents following university visits and public forums by the finalists that will provide opportunities for Nebraska citizens and university constituents to meet the candidates and provide feedback to the Board.
