I. CALL TO ORDER

II. ROLL CALL

The Presidential Search Advisory Committee convened at 3:04 p.m.

Any item before the Committee for action may be approved by an affirmative vote from a majority of the quorum present and votes shall be taken by roll call in rotating alphabetical order.

There being no objection, Phil Bakken was appointed to serve as secretary to the committee. Attendance is indicated above.

Chair Clare announced the location of the Open Meeting Act in the Boardroom.

IV. PRESIDENTIAL SEARCH ADVISORY COMMITTEE CHARGE

Chair Clare gave a charge to the Committee, stating, "The University of Nebraska Presidential Search Advisory Committee is charged with recommending unranked semi-finalist candidates to the Board of Regents. To complete this charge, the Committee is expected to:

- Solicit broad input from the University of Nebraska's campus community regarding the qualities desired in the University's next president.
- Use the Nine Core Leadership Pillars approved by the Board of Regent and qualities identified by the University community to build a Leadership Profile and Advertisement to guide candidate nomination and recruitment.
- Invite nominations and broadly recruit candidates.
- Carefully evaluate candidates against the Nine Core Leadership Pillars and assess institutional "fit" based on input from the entire University community.

In addition, Committee members are expected to:

- Play an active role in all facets of the Committee's work.
- Set aside parochial concerns and act in the best interest of the entire University System.
- Disclose to the Committee Secretary or University's General Counsel any potential conflicts of interest.
- Serve as ambassadors on behalf of the University of Nebraska.
- Understand and agree that the Committee Chair will serve as spokesperson for the search.
- Maintain strict confidentiality throughout the process, respecting the privacy of candidates.
