CHANCELLOR OF THE UNIVERSITY OF NEBRASKA-LINCOLN**

THIS OFFICIAL ACTION is made effective on July 1, 2016, by and between THE BOARD OF REGENTS OF THE UNIVERSITY OF NEBRASKA, hereinafter referred to as the "University" and RONALD D. GREEN, PH.D., hereinafter referred to as "Chancellor Green."

That in accordance with Section 18 of Chancellor Green's Contract of Employment, originally approved by the Board of Regents on May 25, 2016, the following changes to base salary and fringe benefits, are approved:

Section 2. Salary; Authority and Duties of the Chancellor.

- (a) In consideration of an annual Base Salary of \$464,000 (~~\$430,000 Base Salary, plus housing and vehicle allowance below~~) effective July 1, 2016 and the further agreements and considerations hereafter stated, Chancellor Green agrees to accept employment as the Chancellor of UNL. Chancellor Green is appointed by the President and approved by the Board of Regents of the University of Nebraska. Chancellor Green reports to the President and through the President to the Board of Regents. Chancellor Green is the chief executive officer of the UNL campus who also serves as a vice president of the University of Nebraska and has charge of the administration of UNL with all the powers and duties incident to the Office of the UNL Chancellor as such powers and duties are prescribed by law, the Bylaws of the Board of Regents of the University of Nebraska (Bylaws), and policies, rules, regulations and directives duly adopted by the Board.

Section 6, Residence of the Chancellor, and Section 10, Automobile, are accordingly superseded by this modification. For clarification and avoidance of doubt, Chancellor Green will not submit mileage reimbursement requests or other vehicle related expenses to the University.

- ~~(a) As Chancellor of UNL, Chancellor Green's compensation as stated in Section 2 includes an annual housing allowance of \$24,000 annually in accordance with the University's policies and process for non-wage compensation.~~
- ~~(b) Public funds shall not be used to perform construction, maintenance, or repair work on the personal residence of a Chancellor and University personnel shall not be used for such purpose under any circumstances.~~

Section 10. Automobile.

~~As a condition of employment and in the performance of duties as Chancellor of UNL, Chancellor Green's compensation in Section 2 includes an annual vehicle allowance of \$10,000 in accordance with the University's policies and process for non-wage compensation.~~

In all other respects, Chancellor Green's Contract of Employment shall remain unchanged.

IN WITNESS WHEREOF, the parties have executed this First Amendment to Chancellor Green's Contract of Employment on the date first stated above.
