Research Program Building:

2003 to present. The Family Center at Kennedy Krieger Institute is a high volume (~ 1,000 active patients and 19,000 visits per year) community-based mental health center that, over the last 25 years has focused on the treatment of children exposed to child maltreatment (trauma), community and family violence and their family members. In 2003, in the final two years of her K-award, Dr. Belcher was asked to develop a research program at the Family Center. As Director of Research at the Family Center at Kennedy Krieger Institute, Dr. Belcher worked to develop systematic evaluation of all children treated at the Family Center. Since Dr. Belcher began her position as Director of Research, seven trauma-related peer-reviewed articles (15, 18, 19-24), one case study, and one invited program description were published. During Dr. Belcher's tenure, the Family Center has received, one NIH research grant (Research Grant #8), nine years of continuous federal funding from the Substance Abuse and Mental Health Services, National Child Traumatic Stress Network Initiative (See Clinical Extramural Funding, Grants #10-13) and what will be ten years of Centers for Disease Control and Prevention with the recently funded CDC training grant (See Training Grant Funding, Grants #1-3). Nationally, Dr. Belcher was elected to serve on the Steering Committee and Advisory Board of the National Child Traumatic Stress Initiative (NCTSI) (funded by SAMHSA) and currently serves on the Treatment and Outcome, Core Curriculum for Childhood Trauma, and Substance Abuse and Adolescents Committees of the NCTSI. In addition, Dr. Belcher was invited to give three Grand Rounds (Johns Hopkins, Pediatrics and Child Neurology and Uniformed Services University of the Health Sciences), co-developed, moderated, and lectured for one Mid-Atlantic conference "Long Term Consequences of Child Maltreatment: Successful Prevention Strategies and Treatment", instructed two lectures (Johns Hopkins Bloomberg School of Public Health, University of Maryland School of Social Work), and gave two television (WJZ-TV "On Time") and one radio (National Public Radio) interview as a result of her work at the Family Center in the area of child maltreatment and violence exposure.

Educational Program Building/Leadership:

Dr. Belcher was the principal investigator and director of the RISE Program. The RISE Program (U50/CCU325127) was a Centers for Disease Control and Prevention (CDC) grant that provides underrepresented racial and ethnic minority graduate, medical, and recent undergraduates public health research training. The RISE program included a comprehensive Orientation Course including lectures on Health Disparities, Biostatistics, Access database development, Complex Trauma, HIV/AIDS, Teen sexually transmitted diseases and Pelvic Inflammatory Disease, Drug Dependence, Intrauterine Alcohol and Drug Exposure, Attention Deficit Hyperactivity Disorder and other Neurodevelopmental Disabilities conducted by Dr. Belcher and faculty at the Johns Hopkins School of Medicine and Johns Hopkins Bloomberg School of Public Health. Each student was assigned to work with one or two research faculty mentors from the Kennedy Krieger Institute and/or Johns Hopkins School of Medicine or Public Health. The target training goals for the RISE experience were to increase the understanding of research design and implementation, development of research questions, statistical analysis strategies, and development of abstract and research presentation skills are. Since 2005, 66 students from 13 different universities across the nation have participated in the RISE Program. Dr. Belcher personally mentored 21 of the students in the RISE program, producing manuscripts, a book chapter, presentations at George Washington University School of Public Health and for Maryland State Infants and Toddlers program, and multiple platform and abstract presentations to the American Public Health Association (APHA) annual meetings. In addition, Dr. Belcher developed a Research Training Consortium including faculty at Howard University Graduate School, School of Education, School of Social Work and College of Medicine, Coppin University, Department of Applied Psychology and Nursing, and Morgan State University, Department of Psychology and School of Public Health. Students participate in weekly journal clubs during the summer and monthly during the school year. Students prepare a public health presentation that is presented to peers and community members, including local churches and state meetings. Full year students develop an abstract for the American Public Health Association Meeting (APHA). Over 25 students have been selected to present their research at the annual APHA meetings and two other abstracts were accepted at other national and international meetings. Currently, 100% of the undergraduate students who participated in the

RISE program have been accepted into graduate or medical school including, Mailman School of Public Health at Columbia University, Harvard School of Medicine, University of Baltimore, University of Maryland, Bowie State University, and Loyola in Chicago.

In 2011, Dr. Belcher was awarded two 5-year CDC training Programs grants to promote public health careers among under-represented undergraduate and graduate students. The Maternal and Child Health Careers/ Research Initiatives for Student Enhancement-Undergraduate Program (MCHC/RISE-UP) will create a national consortium of universities (including Historically Black Colleges and Universities, Johns Hopkins Medical Institutions and Bloomberg School of Public Health, University of South Dakota, and University of Southern California and partnering California State University-Los Angeles) to promote maternal and child health and public health careers for up to 50 undergraduate students from federally identified under-represented racial and ethnic populations each year. The MCHC/RISE-UP program will use the Leadership Education and Neurodevelopmental Disablities and University Center of Excellence in Development Disabilities program training infrastructures to create three tracks for students, namely (1) clinical, (2) leadership, and (3) clinical tracks at one of four locations, Centers for Disease Control and Prevention, KKI/Johns Hopkins University, University of South California, and University of South Dakota. The James A.Ferguson Emerging Infectious Diseases Fellowship will provide training in infectious diseases for up to 20 pubic health graduate or professional (dental, medication, pharmacy, vetinary) students who are from under-represented racial and ethnic groups).

Clinical Program Building/Leadership:

Dr. Belcher directed and served as the primary neurodevelopmental pediatrician for the Developmental Evaluation and Intervention Program (DEI). During her tenure, the program expanded from a one-county region (Hillsborough County) to five counties (Hillsborough, Polk, Manatee, Hardee, and Pasco) in Florida from 1991-1993, with a commensurate increase in budget from ~\$300,000 to ~\$1,000,000 per year in funding. The DEI evaluated approximately 1500 children a year in Hillsborough County and provided the children with a broad array of home and center-based prevention and early intervention services. The program was designed to follow and promote the cognitive and emotional development of infants of lower socio-economic status who received care in the regional Neonatal Intensive Care Units (NICU). Later, Part H (of the Individuals with Disabilities Act), Infants and Toddlers Early Intervention services were added to the program. As director, Dr. Belcher became aware of the many parents, especially mothers, who were suffering from untreated mental health disorders including: depression, post traumatic stress syndrome, domestic violence, borderline personality disorder, and substance abuse. In response to this neglected need, Dr. Belcher became instrumental in expanding the role of the DEI program psychologists from evaluation to mental health treatment. In addition, she wrote grants to provide comprehensive services for women with drug dependence (Clinical Grant 1), children in foster care (Clinical Grant 2), and grants to expand developmentally appropriate services for providers in the community (Clinical Grant 5-7). Dr. Belcher also hired parents whose children had received care in the NICU to provide parent support and policy guidance for the program. As a result of her committed service to the Hillsborough community she was awarded the "Friends of the Young Child" award in 1993.

Due to her family relocating in 1993, Dr. Belcher accepted a position as Assistant Medical Director for the Exceptional Family Member Program at the National Naval Medical Center. In this capacity, she assisted in establishing an Early Intervention Evaluation and Treatment service for children of military service and State Department personnel who had developmental disabilities. Dr. Belcher provided evaluation and treatment for military dependents in the Washington, D.C. metropolitan area, Quantico and Dahlgren Virginia, and Puerto Rico. While in this position, Dr. Belcher coordinated the Spina Bifida clinic and was a consultant and instrumental in establishing the Early Intervention Evaluation and Treatment program in Puerto Rico. Dr. Belcher earned the Distinguished Civilian Service Medal (highest award given to a civilian by the Navy) for her work with the Navy (Tri-Care) Early Intervention Evaluation and Treatment program.
